





OB Subcommittee Updates

- August 4th meeting <u>minutes & slides</u> now available
- Two new OB measures have been released to the 'All Measures' and 'Obstetric' Dashboards
 - TEMP 05-OB is the percentage of patients who undergo cesarean deliveries under general or neuraxial anesthesia for whom no body temperature was greater than or equal to 36 degrees Celsius recorded within the 30 minutes immediately before or the 15 minutes immediately after the case. Additional measure specification details available <u>here</u>.
 - GA 02-OB is the percentage of cesarean deliveries where general anesthesia was administered after neuraxial anesthesia. Full measure specification details available <u>here</u>.
- Please review the OB dashboard for TEMP 05-OB and GA 02. Consider if the results accurately reflect your practice and if the appropriate cases are being excluded

Cardiac Subcommittee Updates

- September 10th meeting <u>minutes & slides</u> now available
- New post-bypass hypothermia avoidance measure is being validated and will be released to the 'All Measures' and 'Cardiac' Dashboards
 - **TEMP 06-C** is the percentage of adult patients who undergo open cardiac surgical procedures for whom the last non-artifact body temperature prior to anesthesia end was greater than or equal to 35.5 degrees Celsius. Additional measure specification details available <u>here</u>.
- A countermeasure for on-bypass hyperthermia avoidance is also being developed and we're requesting perfusionist input

PAIN 01 and 02 (use of non opioid adjuncts) Attribution

Several sites wish to include measure performance as part of provider emails

Inaccurate to assign attribution related to a specific time period (induction, emergence) due to variation in administration of adjuncts

Decision: assign attribution to all providers providing care

Will not affect sites who wish to view this measure at an institutional level only
