

# **Smoking Cessation**

Measurement Period: **12/01/2021**-11/30/2022


#### **Additional New Measures:**

- Improve smoking status documentation within 30 days prior to surgery. Target: 70%
- Increase the proportion of smokers who receive treatment/cessation counseling. Target: 1%

Coordinating Center to send communication with more details later this week.

New additional reimbursement: 2%\*

\* In addition to the potential 5% from standard VBR



Reviewed measure 11/2022 (Drs. Davies and Bouwhuis)

Discussed "modify" votes with quality champions - most were interested in better EHR tools to complete the handover process and/or include supervising providers



# New QI Project to improve delirium screening in routine clinical setting



### 3 phased approach

Conduct surveys and focus groups with nursing colleagues to determine barriers to delirium screening practices on hospital wards.

Based on barriers identified, conduct a pilot implementation trial with the goal of improving delirium screening frequency and accuracy.
