#### 5. Beaumont - Farmington Hills QI Story - Dr. Joshua Berris & Pam Tyler (ACQR)

- a. Leveraging ASPIRE/EPIC data and questionnaires for practice improvement and reporting
- b. Used Scan Tron "bubble sheets" to collect non-EMR data and reported findings through Excel and VBA
- c. Reported findings to administration, surgery and anesthesiologists through "ERAS Dashboard" every month with personal data and departmental data.
- d. Quality Improvement: LOS prior to implementation was 8.8 days for colorectal cases and dropped to 4 days after implementation.
- e. Discussion
  - i. (Nirav Shah) As we start to enable PACU data extraction our first sites will start to submit enough data to start building outcomes measures. Initial ideas for metrics to focus on are PACU pain and LOS.

## 6. Beaumont – Dearborn/Taylor QI Story – Dr. Katherine Vitale & Mary McKinney (ACQR)

- a. Temp 02 and PUL 01 improvements using ASPIRE data
- b. Created friendly competition between providers by exporting provider list and anonymized their scores using excel.
- c. Performance graphs was distributed to Anesthesia staff each month. An upward trend in TEMP 02 performance was seen after graphs were presented.
- d. PUL 01 improvements: Highlighted IBW incorporated into Epic making it more obvious to providers.
- e. Discussion:
  - i. (Nirav Shah) Were there any noted improvements in TEMP 03 through this initiative as well?
    - 1. ACQR continuing to review cases
- f. (Mike Mathis) System level changes are great strategy in comparison to focusing improvements with individual providers.
  - (Nirav Shah) Epic is going to make IBW display more prominently as part of their foundation build. All sites will be able to include IBW in a more prominent location after the next upgrade from Epic.

### 7. Measure Update - PONV

- a. Add Reglan as anti-emetic?
- b. How often was Reglan used?
  - i. 65,000 cases out of 2.5M general anesthetics last 2 years (2.6% of cases)
- c. Formal vote from Quality Committee on measure changes moving forward. Will be able to make modification to MIPS measures in 2019 with the removal of QCDR participation.
- d. Use of Propofol as an anti-emetic is still pending.

#### 8. Feedback Needed – TRAN 02

- a. **Success:** Hematocrit value documented as less than or equal to 30% and/or hemoglobin value documented as less than or equal 10 g/dL
- b. No hematocrit or hemoglobin checked within 6 hours of anesthesia end

### c. Feedback on Original Proposal from Forum:

- i. Dr. Eric Davies: We need two separate measures. One to see how often and what type of patients we get a post transfusion H/H and a second telling us what the H/H is when it is measured. One needs to understand when and why we are making a measurement to assign meaning to the result.
- ii. Dr. Aaron Wood: Sample case [x] ...To me this seems like good stewardship of resources and would be very reasonable to include as a pass for tran-02.
- iii. Dr. Zachary Price: reasonable clinical judgment should be rewarded and ordering additional tests just to hit a metric seems wasteful

#### d. Assessment and Pan

- i. Failures (Post-op Hct >30) map be occurring with appropriate care
- ii. We may be encouraging inappropriate behavior (not checking post-op Hct) with current measure specification
- iii. We should exclude cases where Hct not measured post-op to prevent this inappropriate behavior
- iv. Need to discuss if changes are needed to TRAN 02 (will convene a smaller meeting to follow) to make it more relevant.
