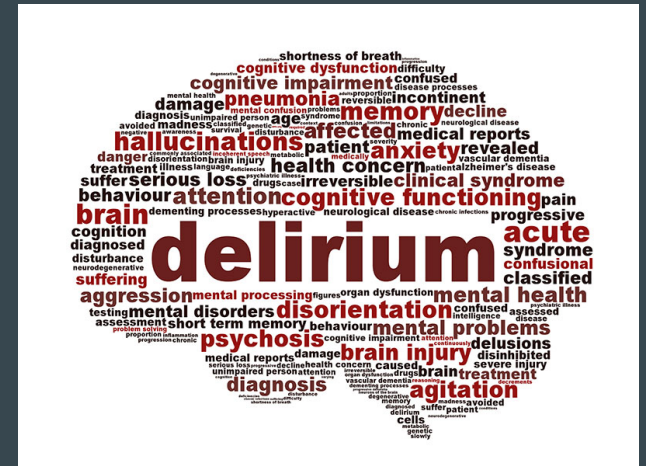

Precision Feedback Study

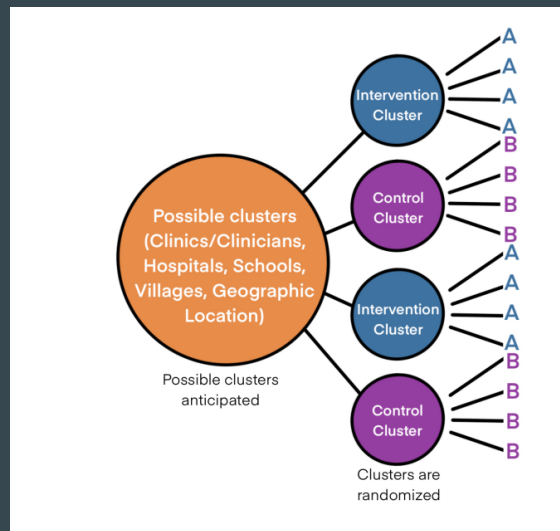
NIH -funded R01 award to implement and evaluate precision feedback

Team (led by Zach Landis-Lewis, PhD) preparing to conduct an MPOG-wide cluster-randomized controlled trial in 2023

Plan to include many institutions that currently receive the MPOG provider feedback email

In preparation for the trial we are conducting a preference survey, open to all MPOG-participating providers

QI Snapshot 2022

Sites participating in QI: > 90%

MOCA: 815 enrollments

Provider feedback: > 7,000

New Measures: BP 05, SMOK 01, SMOK 02, SUS 02, SUS 04, SUS 05 (PEDS), TRAN 03 (PEDS), TRAN 04 (PEDS), NMB 03 (PEDS), PONV 04 (PEDS), PONV 05, TEMP 06 (CARD)
