## Clinical Onboarding Overview

During the Clinical Onboarding process, the MPOG Clinical Informatics Specialist (CIS) will work with your site's team to review and validate your data. The CIS will guide your team through the steps necessary to successfully submit clean, quality data to MPOG Production.

The CIS is notified when your site completes Technical Onboarding and will reach out to your team to start scheduling Clinical Onboarding meetings.

### **Pre-Onboarding Requirements**

Prior to Clinical Onboarding, the following steps and documents MUST be completed.

- Complete Steps 1-5 under the Steps to Join page <a href="https://mpog.org/stepstojoin/">https://mpog.org/stepstojoin/</a>
- Submit signed Regulatory and Security Documents
  - Business Associate Agreement (BAA)
  - Data Use Agreement (DUA)
  - The remaining documents must be completed prior to receiving approval to submit data to MPOG Production
    - Institutional IRB
    - MPOG Bylaws
    - MPOG Service Agreement
- Complete Technical Onboarding with MPOG Technical Team

## Clinical Onboarding Details

The <u>Clinical Onboarding Process</u> includes multiple rounds of data review and validation. The user guides for all of the tools used during this step can be found on our <u>website</u>. The CIS will guide you through each step and teach you how to use the tools.


The MPOG Clinical Onboarding Roadmap shows a breakdown of the Clinical Onboarding steps and an estimated time for each step to be completed. It's important to remember that the time given is an estimate, which may vary and could take longer depending on your team's availability to work on MPOG data, any data issues that are discovered, or any other delays that may be encountered. Epic sites are estimated to take 6 months – 1 year to complete, while non-Epic sites are estimated to complete onboarding in 18 months-2 years. The CIS will update the roadmap to reflect where your site is in the process.

The MPOG CIS will set up meetings on a schedule that works best for your team. Some sites like to meet on a regular schedule, while others prefer to meet on an ad hoc basis. The CIS will keep your team informed on the next steps in the process and will help with troubleshooting any data issues that are found along the way.

#### Clinical Onboarding Steps

- 1. Variable Mapping (1 month of data)
- 2. Location Mapping
- 3. Case Validation (minimum of 5 cases/month of data)
- 4. Data Diagnostics Attestation
- 5. Review additional MPOG tools
  - a. Case Viewer
  - b. Import Manager Assistant
  - c. Content Synchronization
  - d. Concept Browser
- When approved, meet with CIS to complete PHI Scrub and Transfer 1 month of data to MPOG Test environment
  - a. MPOG Coordinating Center will complete a review of this data and send a summary of our recommendations, and any data issues encountered
- 7. Site to complete recommendations and resolve data issues from MPOG Coordinating Center
- 8. Load additional 3 months of data (for a total of 4 months)
- 9. Repeat steps 1-4 for each additional month
- 10. **When approved**, meet with CIS to complete PHI Scrub and Transfer 4 months of data to MPOG Test environment
  - a. MPOG Coordinating Center and MPOG Directors will complete a review of this data and send a summary of our recommendations, and any data issues encountered
- Site to complete recommendations and resolve data issues from MPOG Coordinating Center
  - a. Depending on how the data looked during the 2<sup>nd</sup> Test upload, the MPOG Coordinating Center may require an additional upload to the Test Environment after the issues have been resolved.
- 12. Load additional data until you have caught up to current time, repeating steps 1-4 for each additional month.
- 13. <u>When approved</u>, meet with CIS to complete PHI Scrub and Transfer 1 year of data to MPOG Production
- 14. Automate the File Extract and the Import and Consume process
- 15. Follow the MPOG Maintenance Schedule and submit data monthly to remain an Active MPOG Site.
